Assurance on testing: Written assurance must be supplied by the **applicant company, subsidiaries and parent company or their subsidiaries** have not commissioned any form of live animal testing on individual ingredients or their finished products after the cut off date.

Written assurances must be supplied confirming that specific ingredients have not been tested by the ingredient supply company.

Products may not contain ingredients that have been required by law to be tested on animals (or from animal data) after the cut off date
